 - Signature paper submissions will go to Mrs. Cross.
- Voting: secure Google form, in-person voting.
- Counting and oversight: results tallied immediately.
- Results and transition
 - Outgoing officers brief incoming officers.
- SGA and class officer elections will be conducted during a mandatory admin meeting, candidates will give an elevator speech (can read off personal statement), voting will occur at the end of the meeting with entire student body.
- o Club elections will also be held in person at their respective club meeting.
- Clarification on club elections: candidates will choose one position they
 would like to run for, read their statement. There will be one pre-made
 Google poll with voting for all positions and candidates. Any unfilled
 positions will be open to those who ran but didn't get their preferred position.
- A fully delineated email with elections details will be sent out with feedback from today's SGA meeting.
